



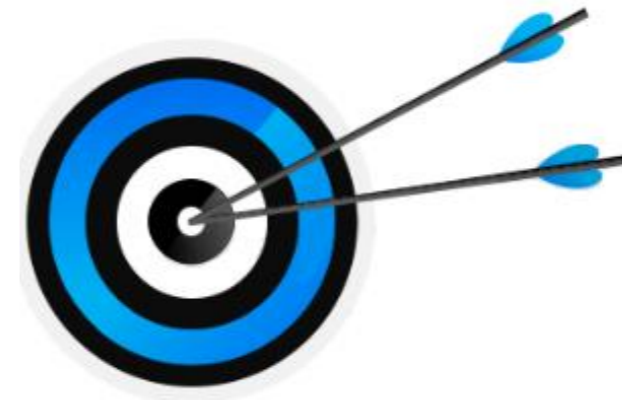

LEADERSHIP INCOME - LEVEL 1 = 30%

You must have 3 Direct sponsored by you

Whenever you sponsor any person, he will be placed direct under you and you will get 30% of his total earned income from Referral plus Level income.

*E.g. : you have 20 direct person and all of them earn ₹ 10000 from their **referral and level income**, you will get ₹ 3000 from each of them i.e. ₹ 60000/-*



LEADERSHIP INCOME - LEVEL-2 = 10%

You must have 5 total direct sponsored by you.

All the persons sponsored by your Direct persons will be placed under you at level -2

You will get 10% of the total income earned by all the persons placed at level 2.

E.g. Your directs are-20 and all of them have 5 directs. So at your level 2 there will be 100 people.

If they all 100 people earn ₹ 10000 each, you will get ₹ 1000 x 100 = ₹1000000.

ELABORATION: LEADERSHIP INCOME

- YOUR DIRECTS: 20 (LEVEL-1)
- DIRECTS OF YOUR DIRECTS (5 each) =100

Total Team : 121 (including yourself)

Each one earns : ₹ 10000/-

Your Total Income (Example)

- Your personal payout : ₹ 10000/-
- From Level 1: ₹60000/- (30% of 10000*20)
- From Level 2: ₹ 100000/- (10% of 10000*100)

You will earn ₹10000 + ₹ 60000+ ₹100000
= ₹ 170000/- (One Lac Seventy Thousand only)

SILVER CLUB INCOME

DIAMOND CLUB INCOME

- ✓ *He must have **3 Gold** qualifiers from his team.*
- ✓ *Total monthly sale from his team should be **₹ 900000/- (nine lacs)***



ELABORATION – CLUB INCOME

Total Sale of the month: 1500

Average cost: 4000

Total sale Amount: 6000000

Share in Silver club @ 4 % = 240000

Participant in Silver club = 10

Share per head = $240000/10 = 24000$

Share in Gold Club @ 3% = 180000

Participant in Gold club = 5

Share per head in Gold Club = 36000

Share in Diamond Club @ 2.5% = 150000

Participant in Diamond club = 2

Share per head in Gold Club = 75000

If you are in Diamond Club, you will get all three club incomes

24000+36000+75000= 135000

(one lac thirty five in a month.)
